In response, 05 bids were received till the bid opening date 06-10-2021 and 03 bidders were qualified (Apollo Telecom, Kontinental Establishment & SeeSam Solutions). M/s Apollo Telecom & M/s Kontinental Establishment offered the lowest bids but the technical specification were not as per requirements as mentioned in floated tender document whereas the bid offered by M/s SeeSam Solutions (Pvt) Limited was much higher than estimated cost.

In view of the above, it is recommended by the procurement committee (minutes attached) that the tender be cancelled and the process of tender be initiated.



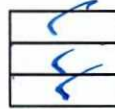
