

Subject: CANCELLATION OF TENDER FOR SUPPLY & INSTALLATION OF IT EQUIPMENT EPADS-S-241180944

The Tender regarding Supply & Installation of IT Equipment was floated on 15-11-2024. In response, we had received four bids on the bid opening date i.e, 04-12-2024. Bids were opened and the lowest bid was of M/s Roomi Enterprises. M/s Kontinental Establishment filed a complaint in Complaint Redressal Committee and the Committee decided that no violation of SPPRA Rules was made. Later, M/s Kontinental Establishment lodged an appeal in Review Committee of SPPRA. The Review Committee convened its meeting on February 26, 2025 but no decision has been made / received despite two reminders dated May 13, 2025 & May 23, 2025. A final letter was also written to SPPRA Review Committee on June 10, 2025 intimating them regarding cancellation of the bidding process as per Rule-25 of SPPRA Rules.

In view of the above, it is recommended by the Procurement Committee that the Tender for supply & installation of IT Equipment be cancelled and the process of re-tender be initiated.


Dear Sir,






